## POSB Everyday Card 10% Cash Rebate On Weekend Dining and Online Grocery Shopping ("Weekend Promotion") Terms and Conditions

1. POSB Everyday Cardmembers will enjoy 10% rebate on weekend dining and online grocery shopping during each eligible weekend period from 4 - 5 Oct, 11 - 12 Oct, 18 - 19 Oct and 25 - 26 Oct 2014 (each an "Eligible Weekend"), subject to a minimum spend of S\$300 ("Total Account Spend") charged to the POSB Everyday Card ("Card") during the Eligible Weekend. The amount of rebate is capped at S\$50 per POSB Everyday Card account.

Weekend dining spend includes spend made at restaurants, cafes, fast food outlets and caterers but excludes food and beverage spend made at hotels, bars, entertainment establishments and wedding banquets. For each POSB Everyday Card account which qualifies for the Weekend Promotion, 0.3% rebate will be credited upfront and the additional 9.7% rebate will be credited on eligible spend by 31 January 2015. For spend at Sheng Siong, 5% rebate will be credited upfront and the additional 5% cash rebate will be credited by 31 January 2015.
