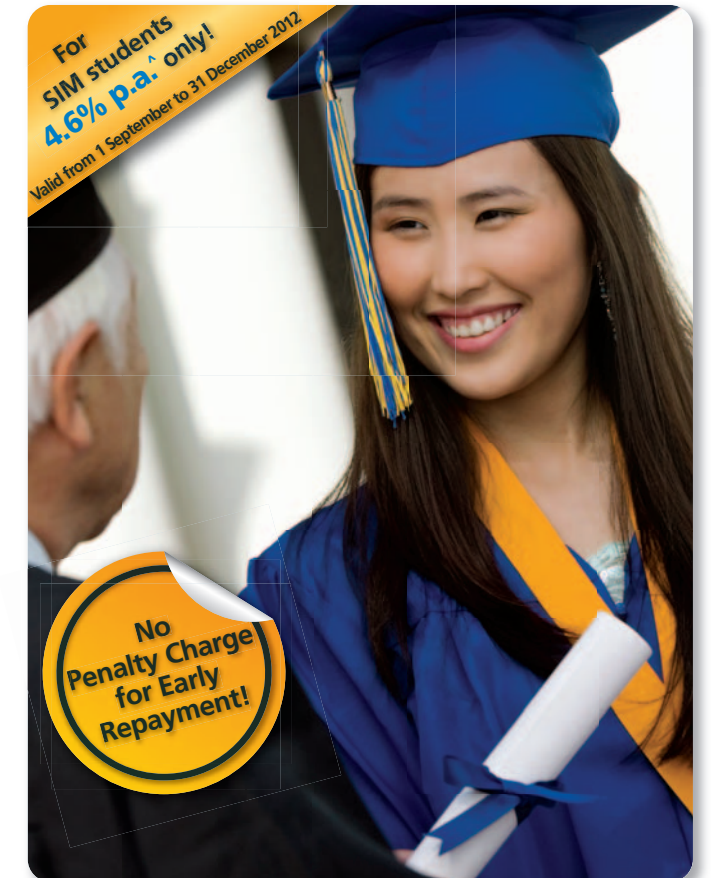

- Between 17 and 50 years of age.
