

# <u>Terms and Conditions Governing PayNow-PromptPay Welcome Reward 2025 Promotion</u> ("Promotion")

Participation in this promotion constitutes acceptance of these Terms and Conditions.

- 1. The Promotion is valid from 1 January 2025 to 31 December 2025. ("Promotion Period"), both dates inclusive.
- 2. Eligible Customer ("New PayNow-PromptPay Customer") are defined as customer who has not used PayNow-PromptPay via digibank mobile within the last 12-months.
- 3. Eligible PayNow-PromptPay transaction ("Eligible Transaction") is defined as a PayNow-PromptPay transaction from an account maintained with DBS Singapore accumulated within the Qualifying Period via digibank mobile.
- 4. The Personal Deposit, Current Account and/or Savings Account used must be in good standing and must not be voluntarily or involuntarily delinquent, closed, suspended, or terminated throughout the Promotion Period and at the Reward Credit Date.
- 5. To qualify for the Promotion, New PayNow-PromptPay Customer must fulfil the following qualifying criteria below to receive a \$\$12 cashback ("Reward"):
  - a. Be within the first 200 New PayNow-PromptPay Customers to accumulate a minimum of S\$300 equivalent of Eligible Transactions within the Qualifying Period where the first Eligible Transaction is made (as defined in Clause 7).
- 6. Regardless of multiple Eligible Transaction made, each New PayNow-PromptPay Customer will only be entitled receive one Reward during the Promotion Period.
- 7. Reward will be credited into the bank account used by New PayNow-PromptPay Customer to perform the first Eligible Transaction within a Qualifying Period shown below, given that the Eligible Customer has fulfilled all the criteria under Clause 3.

#### General

- 8. DBS reserves the right, at any time without giving any reason or notice, to withdraw or cancel any cashback awarded to customers without liability.
- 9. DBS will have the final decision on all matters regarding the Promotion.
- 10. DBS may change these terms or suspend/terminate the Promotion without giving notice.
- 11. Notwithstanding anything herein, DBS has the absolute discretion to determine the eligibility of any person to participate in the current and upcoming Promotion.
- 12. DBS shall not be obliged to enter into any correspondence on any matter concerning the Promotion.
- 13. By participating in this Promotion, participants agree to release and hold DBS harmless from any and all liability whatsoever for any injuries, losses or damages of any kind to any person or property arising from or in connection with, either directly or indirectly:
  - a. DBS will not be responsible for any injuries, loss, claim, or damage suffered or incurred in connection with the Promotion (including but not limited to any error in computing any qualifying transaction, any breakdown or malfunction in any computer system or equipment), Prize and/or any notices, letters or correspondence lost, stolen, or misdirected in the postal system or telecommunication system, and the consequences arising from the non-receipt of such communication.
  - b. the awarding, acceptance, receipt, possession, use or misuse of any Prize or parts thereof awarded pursuant to the Promotion; and
  - c. the participation in the Promotion or any Cash Credit-related or any prize-related activities.
  - d. DBS' decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.

New PayNow-PromptPay Customer consent to the collection, use and disclosure of their personal data, including personal data in DBS possession, by/to DBS and such other third party as DBS may reasonably consider necessary for the purpose of administering the Promotion, and confirm that they agree to be bound by the terms of the <u>DBS Privacy Policy</u>.
- 17. New PayNow-PromptPay Customer consents to DBS offering the Eligible Customer products/services that may be of interest to the New PayNow-PromptPay Customer for



marketing purposes in connection with Promotion. Such marketing messages may be sent via email, regardless of New PayNow-PromptPay Customer's registration with the National Do-Not-Call Registry. This consent will override New PayNow-PromptPay Customer's existing marketing consent with DBS.

### Frequently Asked Questions on PayNow-PromptPay Welcome Reward 2025 Promotion

## 1. Is any registration required? How do I take part in this PayNow-PromptPay Welcome Rewards Promotion?

No registration is required. This promotion is open to customer who are using PayNow-PromptPay via digibank online or digibank mobile for the first time and did not perform PayNow-PromptPay fund transfer within the last 12-months. All you need to do is accumulate a min S\$300 equivalent with PayNow-PromptPay within a Qualifying Period (as defined in Clause 7) and be the first 200 customers to accumulate a minimum of S\$300 of each Qualifying Period.

### 2. What is counted as an eligible transaction?

Based on your PayNow-PromptPay transaction submission date, if it was done during the qualifying period, it will be counted as an eligible transaction.

#### 3. When and which account will the S\$12 cashback be credited into?

If you have fulfilled all the criteria under Clause 5 of Promotion <u>Terms and Conditions</u>, reward will be credited into the bank account used by Eligible Customer to perform the first eligible transaction. The reward credit date for each qualifying period is detailed in below table:

## 4. Am I able to combine Eligible Transactions across different Qualifying Periods?

No, eligible transactions must be accumulated within the same qualifying period. Below are 3 scenarios to illustrate if customer fulfils the criteria under Clause 5 and 7: **Terms and Conditions**.
