

DBS PayLah! x Yeo's Scan to win 2024

Terms & Conditions

1. The Contest

- 1.1. In these terms and conditions, "DBS PayLah!" refers to a mobile service offered by DBS that may be used by a user of the mobile service (individually a "User" and collectively, "Users") to transfer funds via the DBS PayLah! application for mobile devices that can be downloaded by Users from the Apple App Store and Google Play Store ("Application").
- **1.2.** The DBS PayLah! x Yeo's Scan to win 2024 ("Contest") is hosted in DBS PayLah! and shall run from 6:30AM to 12:00PM on 17 November 2024 ("Contest Period").
- **1.3.** During the Contest Period, Eligible Users (as defined in Clause 2.1 below) stand a chance to win cash amount (individually a "Cash Prize", and collectively "Prizes") or Yeo's Supersprout premium (individually a "Premium", and collectively "Premiums") by scanning QR code that is shown at Yeo's booth during the POSB Run For Kids event at Promontory @ Marina Bay.

2. Eligibility

- **2.1.** The Contest is open to eligible users who:
 - a) Have successfully downloaded the Application before or during the Contest Period; and
 - b) have successfully registered for a PayLah! account in the Application ("PayLah! Account") before or during the Contest Period (individually an "Eligible User" and collectively, "Eligible Users").
- **2.2.** To participate in the Contest, Eligible Users must have successfully scanned the DBS PayLah! QR Code on the Scan to win A4 poster that are allocated at The Promontory @ Marina Bay during the Contest Period.

3. Prize

- **3.1.** The Prizes (Cash prizes or premiums) shall be allocated randomly and the quantum of each Prize is random.
- **3.2.** Eligible Users who win a Cash Prize (individually a "Winner", and collectively "Winners") will have the Cash Prize credited to either the Winner's PayLah! account or the bank account which is linked to their PayLah! account ("Bank Account") on the day that the successful scan was made, or on any other date which DBS may at its sole discretion determined, provided that the PayLah! Account is not closed or blocked when the Cash Prize is being credited.

- **3.3.** In the event that Cash Prize has not been accorded upon completion of scanning QR code, the Cash Prize will be credited into the PayLah! account of Qualified Users within fourteen (14) working days.
- **3.4.** Eligible Users who win a premium (individually a "Winner", and collectively "Winners") will have to redeem from the Yeo's booth by flashing the screenshot of the "SIP SIP HOORAY! You've scored a Supersprouts premium!" message. Failure to redeem the prizes on the actual day of the event will be considered as forfeiture of the prizes.

4. General

- **4.1.** Participation in the Contest constitutes acceptance of these terms and conditions.
- **4.2.** Participants consent under the Personal Data Protection Act (Cap 26 of 2021) to the collection, use and disclosure of the participants' personal data by/to the organizers, promoters or conductors of the Contest and such other third party for the purpose of administering the Contest and the participants confirm that they have read and agree to be bound by the terms of the DBS Privacy Policy, as may be amended, supplemented and/or substituted by DBS from time to time, a copy of which can be found on www.dbs.com/privacy.
- **4.3.** The decision of DBS on all matters relating to or in connection with the Contest shall be final and binding on the participants of the Contest. No correspondence or claims will be entertained.
- **4.4.** DBS shall not be liable in any way to any participant of the Contest or any other person for any injury, loss, damage or expense arising out of or in connection with the Contest and the Prizes.
- **4.5.** DBS may, at any time at its sole discretion and without prior notice, vary, modify, delete or add to these terms and conditions or suspend, postpone or terminate the Contest or shorten or extend the duration of the Contest without prior notice or any liability to any person.

- **4.7.** In the event of any inconsistency between these terms and conditions and any brochures, FAQs, marketing or promotional material relating to the Contest, these terms and conditions shall prevail.
