

**POSB Everyday Card 10% Cash Rebate On Flights Purchased at AirAsia.com and Overseas Spend (“AirAsia and Overseas Spend Weekend Promotion”) Terms and Conditions**

1. POSB Everyday Cardmembers (“Cardmembers”, each a “Cardmember”) will enjoy 10% cash rebate on flights purchased at AirAsia.com during each eligible weekend period from 22 - 23 Nov, 29 - 30 Nov, 6 – 7 Dec, 13 – 14 Dec, 20 – 21 Dec and 27 – 28 Dec 2014 (each an “Eligible Weekend”) subject to a minimum charge of S\$300 (“Total Account Spend”) charged to the POSB Everyday Card (“Card”) in a single transaction during Eligible Weekend and only applicable for Singapore outbound flights purchased at AirAsia.com, excluding add-ons (baggage, in-flight meals, etc), and any airport taxes, duties and fuel surcharges. 0.3% cash rebate will be credited upfront and the additional 9.7% cash rebate will be credited by 31 March 2015. Each Cardmember is only eligible to receive maximum of S\$50 cash rebate for the AirAsia Weekend Promotion.
2. Cardmembers will also enjoy 10% cash rebate on overseas spend during each “Eligible Weekend” subject to a minimum total spend of S\$1,000 charged to the Card within the same calendar month and capped at Daily\$100 per Card account per calendar year for the Overseas Spend Weekend Promotion. The 10% cash rebate is not applicable for card-not-present transactions such as online transactions, mail/phone order in foreign currencies. 0.3% cash rebate will be credited upfront and the additional 9.7% cash rebate will be credited by 31 March 2015.
3. The Total Account Spend is based on posted local and foreign retail sales, posted 0% interest-free instalment plan, posted recurring bill payment but excludes interest, finance charges, cash withdrawal, balance transfer, smart cash and all fees charged by DBS. For avoidance of doubt, supplementary cardmembers are not eligible to participate in the Air Asia and Overseas Spend Weekend Promotion; however, supplementary card spend can be included in the calculation of Total Account Spend.
4. DBS assumes no responsibility for any loss or damage or expenses arising in connection with the Air Asia and Overseas Spend Weekend Promotion, howsoever arising, including without limitation, from any late or non-notification, any error in computing, technical hardware or software breakdown, malfunctions or defects, failed, delayed or incorrect transactions, or lost or unavailable network connections, or any notice that is lost or misdirected, which may affect a Cardmember’s eligibility in the Air Asia and Overseas Spend Weekend Promotion.
5. DBS makes no representation to the quality or performance of the goods and services provided by the merchants/ partners/ vendors in connection with this Air Asia and Overseas Spend Weekend Promotion.
6. These Terms and Conditions shall be read in conjunction with the DBS Cards General Promotions Terms & Conditions. In the event of any inconsistency, these Terms and Conditions shall prevail insofar as they apply to the Air Asia and Overseas Spend Weekend Promotion. 7. DBS’ decision on all matters relating to the Air Asia and Overseas Spend Weekend Promotion is final and binding on all Cardmembers. DBS shall not be obliged to enter into any correspondence on any matter concerning the Air Asia and Overseas Spend Weekend Promotion.
8. DBS may vary these Terms and Conditions without notice, or withdraw or discontinue the Air Asia and Overseas Spend Weekend Promotion at any time without any notice or liability to any party. In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or promotional materials relating to the Air Asia and Overseas Spend Weekend Promotion, these Terms and Conditions shall prevail.
9. Cardmembers consent under the Personal Data Protection Act (Cap 26 of 2012) to the collection, use and disclosure of Cardmembers’ personal data by/to the DBS’ agent or vendors and such other third party for the purpose of the Air Asia and Overseas Spend Weekend Promotion, and confirm that they have read and agree to be bound by the terms of the DBS Privacy Policy, as may be amended, supplemented and/or substituted by DBS from time to time, a copy of which can be found on [www.dbs.com/privacy](http://www.dbs.com/privacy).
10. These Terms and Conditions are governed by Singapore law and the Cardmembers agree to submit to the exclusive jurisdiction of the Singapore courts.

A person who is not a party these Terms and Conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these Terms and Conditions and notwithstanding any terms herein, the consent of any third party is not required for any variation (including any release or compromise of any liability) or termination of the Air Asia and Overseas Spend Weekend Promotion.
